

Fees and penalties price list

I.

In accordance with the Rules of the Halls of Residence TUO_LEG_07_07 this price list is issued in order to regulate fees and penalties for damages caused on VSB-TUO properties, accommodating services provided as well as fees being charged in case the Rules of the Halls of Residence and Regulations of VŠB-TUO are violated by accommodated persons. See the price list in attachment No. 1 of this notice.

II.

The payment will be performed (according to the price list):

- a) encashment in the frame of entire debts for accommodation being filed in the information system of the dormitories for the actual and previous months or
- b) by bank card or in cash at the Accommodation office or at the Cash desk office of the Accommodation Services within 3 working days,
- c) via EPS (electronic payment system) within three working days,
- d) the contractual penalty for early termination of the Housing contract is payable at the time of early termination of the Housing contract.

If the debts will not be paid then art. 13 of the Rules of the Halls of Residence and art. 4 of the Housing contract will be applied on the debtor.
