### **Within the accommodation, the applicant requests the provision of the following services:**

- 1) Cleaning according to the Operating Rules TUO\_LEG\_10\_003 as amended (i.e. the housekeeper performs at least once every 3 months a general disinfection of rooms and sanitary facilities)

- 2) **Garbage removal by the housekeeper** every working day

YES  (rubbish bin will be located in the space behind the main door)

NO  the applicant is aware that he carries out the waste himself. Mixed waste containers are located behind the A-B reception at the hotel car park. Containers for sorted waste are located in hall A-B. Storing garbage in the room even after notifying the staff of the Accommodation Services about the removal may lead to the termination of the Housing contract.

**The applicant declares that in case of using his own appliances (small household appliances),** these appliances are in perfect technical condition and used according to the manufacturer's instructions. In the event of any fault, the defective appliance will be taken out of service immediately and the applicant will arrange for a professional repair at his own expense.

**The written consent** of the accommodation provider **is required for the use of large household appliances** by the applicant.

Of the large household appliances, it is **possible to use an automatic washing machine / washer-dryer** - only one machine. In the event that the applicant wants to use his own washing machine, it is necessary to connect the washing machine by the employee of the Accommodation services and after the termination of the Housing contract make it disconnected again by the employee of the Accommodation services. Each action is charged 300 CZK. The prerequisite for connecting the appliance is its perfect condition. The applicant shall also **prove himself with a valid insurance contract** on liability insurance for damage

**The applicant acknowledges that in the event of damage to the applicant's property and the landlord's property** as a result of using the appliance in violation of Article 6 of the Dormitory Rules TUO\_LEG\_07\_007 as amended (hereinafter "Dormitory Rules"), the applicant is fully liable for damages and he is obliged to pay these in full.

The rooms are equipped with **smoke sensors, which are connected to the EFA** (electronic fire alarm) and then to the centralized security desk of the relevant fire and rescue service. In case of firefighters' arrival due to a false alarm (poorly ventilated cooking room, smoking in the room), this arrival will be paid in full by the applicant.

**The applicant will in no case interfere** with electrical installations, water distribution and waste.

**Checks according to the Dormitory Rules** can be performed in this room only in the presence of the accommodated person on the basis of a previous request once a month, in case of detected problems even more often. By this point, however, persons are not exempted from complying with the Dormitory Rules.

Employees are allowed to enter the room in case of emergencies.

**Visits to the rooms are governed by the Dormitory Rules.** Payment for the visit is exempted from the double apartment, which is occupied by one person and pays properly for both beds. However, the applicant is not exempted from having to report a visit to the reception of the building.
